4. NEW BUSINESS

(a) Affordable Housing Strategy Implementation - Quarterly Report to Council (2022 Q4)

M. Dickinson overviewed the next quarterly report to Council that provides an update on the City's progress towards the implementation of the Affordable Housing Strategy. The report will be presented at the next regular Council meeting.

It was noted that a survey on secondary suites is available at engage.mission.ca and it will remain open until January 15, 2023.

(b) Affordable Housing Strategy Implementation

- i. SARA for Women Project Updates
 There were no updates at this time.
- ii. Housing Coordinator Updates
 - D. Kae Beno provided an overview on some of the tasks being working on:
 - development of a Standards of Maintenance bylaw and policies to reduce the impacts on affordable housing by development (i.e., renovictions) and to support the preservation of affordable housing;
 - · tenant rights and landlord responsibilities;
 - creation of an affordable housing reserve fund, including the collection of various types of contributions such as cash in lieu from density bonusing program, CACs, and other voluntary sources;
 - internal (City departments) and external engagement in early in 2023 regarding the reserve fund;
 - a series of shared learning sessions, with other municipalities that have these reserve funds in place already;
 - analyze the current and future needs of affordable housing in Mission to determine how much potential housing is needed and what type of housing with the possibility to either secure built affordable housing units or receive cash contributions into the reserve fund;
 - an affordable housing dialogue series in early 2023 to bring in all partners (i.e., developers, the City, BC Housing, faith communities, and other major players) to support affordable housing and non-profit organizations to help them in developing opportunity for managing affordable housing:
 - build a solid foundation of financial tools, have conversations with senior levels of government, pursue grants; and
 - an RFP (request for proposal) will be going out for an economic consultant to assist with the CAC and density bonus updates.
